## New law makes adoption faster, simpler

MANILA -- President Rodrigo Duterte has signed into law a bill that simplifies the adoption process and grants amnesty to those who tampered records to make it appear an adopted child was born to a person who is not the biological mother.

The President signed the Republic Act 11222 or the Simulated Birth Rectification Act on February 21. A copy of the law was released by Malacañang on Thursday.

The new law shall "grant amnesty and allow the rectification of the simulated birth of a child where simulation was made for the best interest of the child, and that such child has been consistently considered and treated by the person" who considered the child as his or her own.

It also aims to fix the status and filiation of a child whose birth was simulated by giving such child all the benefits of adoption and ensuring that such child shall be entitled to all

the rights provided by law to legally adopted children, "without discrimination of any kind, as well as to love, guidance, and support from the child's adoptive family".

For couples where one of the adopters is a foreigner married to a Filipino, the foreigner must have been residing in the Philippines for at least three years before the filing of the petition for adoption.

Instead of going through court proceedings, those who seek to adopt a child may file a petition with the social welfare and development officer of the city

### Sexagenarian, 3 others nabbed for credit card fraud

MANILA – Four persons, including a senior citizen, were arrested for credit card fraud and falsification of documents in Metro Manila, the National Capital Region Police Office (NCRPO) said Thursday.

Maj. Gen. Guillermo Eleazar, NCRPO director, identified the suspects as Czarynah Datu, 37; Paul Cabalza, 45; Eduardo Nera Jr., 41; and Teresita Caranglan, 61, who were arrested in separate operations on Wednesday.

The operation stemmed from a call received by police from a security officer of Resorts World Manila complaining that Datu used a credit card in a fraudulent transaction after she tried to withdraw money.

Police officers arrested Datu after verifying with Banco de Oro that the card was indeed used fraudulently. Seized from her where one mobile phone, one

BDO Forever 21 Master Credit Card and several suspected fake IDs all bearing the name of a certain Jasmine Raymundo.

Datu eventually told police about her cohorts which led to follow-up operations, resulting in the arrest of the other three suspects in Manila and Quezon City.

During the follow up operations, police seized a skimming device, a Louis Vuitton booklet containing different card information and contact numbers of prospected subjects, credit cards, and identification cards from the suspects.

"We continue to remind our fellow Filipinos to beware of scammers and criminals. They are just around the corner. Still, the NCRPO is always ready to protect our people," Eleazar said. (PNA)

## DBM recommends issuance of EO for state workers' pay hike

MANILA -- The Department of Budget and Management (DBM) has recommended to Malacañang the issuance of an executive order (EO) to implement the fourth tranche of salary hike for state workers.

This, as Congress has yet to submit to the Palace the enrolled copy of the PHP3.757-trillion 2019 national budget, amid allegations that members of the House of Representatives made some changes on the Bicameral Conference Committee-approved national budget.

Since the government is operating on a reenacted budget to date, DBM officer in charge and Undersecretary Janet Abuel said they cannot implement the fourth tranche of the wage increase scheduled for this year. Thus, she cited the need for "some additional recommendations for funding."

"But definitely we would like to allay the fears of government employees that the reenactment would prevent the grant but that would require an Executive Order to be issued by the Pres-

ident, which the DBM has already recommended," she said in a press briefing Wednesday.

Amid the budget impasse, Abuel said economic officials "are hoping for the enactment of the 2019 GAA."

DBM officials have said that the last tranche of pay hike under the Salary Standardization Law (SSL) of 2015 will require about PHP45 to PHP50 billion.

Compensation adjustments for employees of national government agencies will be sourced from the national budget while for those belonging to government-owned and controlled corporations, the budget has to come from their respective corporate funds. (PNA)
